Notes on Booking

🐹 Rental price includes all taxes, all gas, and electricity. Towels, including pool towels are also included in the price.

🐹 From 2025 there will be a £80 cleaning fee irrespective of duration of stay.

🐹 There is a separate charge for pool and spa heating. Please refer to rates if heating is required.

🐹 Bookings will be held for up to 7 days pending receipt of completed booking form together with £100 per week non-refundable deposit to confirm booking.

🐹 Cancellation refunds as follows:

- Up to 8 weeks - no cancellation charge
- 4-8 weeks - 50% of rate refunded
- 2-4 weeks - 25% of rate refunded
- Less than 2 weeks - no refund

🐹 The villa is available from 4p.m. local time on the day of arrival and is to be vacated by 10.00 a.m. on the day of departure (unless previously agreed with the owner).
